1. ASSUMPTION OF RISK - I understand that participation in dog training involves inherent risks, including but not limited to the risk of injury to myself, my dog, or others. I voluntarily assume all risks associated with participation in any training session, class, or related activity conducted by Divine Dog Training (the "Trainer") at any facility.

2. RESPONSIBILITY FOR DOG AND BEHAVIOR - I accept full responsibility for the actions and behavior of my dog before, during, and after training sessions. I understand that while the Trainer will make every reasonable effort to help me achieve my training goals, behavior modification is not guaranteed and depends on many factors, including my continued management and practice at home.

3. HEALTH AND VACCINATIONS - I confirm that my dog is in good health and up to date on all required vaccinations, including rabies, and is free from contagious diseases or parasites.

4. RELEASE OF LIABILITY - I agree to release, indemnify, and hold harmless Divine Dog Training, its owners, trainers, employees, volunteers, and representatives, as well as the owners of the facility where training classes occur, from any and all liability, claims, damages, or expenses (including legal fees) arising out of or in connection with my participation in training sessions or my dog's behavior, including injury or damage to any person, animal, or property.

5. PHOTOGRAPHY AND MEDIA RELEASE - I give permission for Divine Dog Training to use photographs or videos of my dog and/or myself taken during training for educational or promotional purposes.
